I, the above-named and under-signed, do hereby understand and give a 50% **nonrefundable deposit** to hold my charter date. Remainder is to be paid in full no later than 30 days prior to charter date. Only corporate, bank cashier or travelers' checks, money orders and cash can be accepted for payments. **No cancellations or date changes can be made after the deposit is paid due to scheduling conflicts.** I fully accept that JT's takes the boat off the market and would lose revenue for not being able to reschedule another charter. I also understand that weather or other conditions might delay or prevent the start, cause early termination and/or postpone the charter. If the charter is postponed by JT's due to unsafe conditions, the payments will be applied to a new date, subject to availability. **Sorry, NO REFUNDS as no money can be returned!** Rescheduled charter must be completed within same season as postponed date. If my group, caterer, musician, or other person(s) or event(s) delay(s) the charter's start time, no money will be returned, and no time can be credited. I agree to pay all damages and inform all participants of charter's requirements so that everyone will arrive properly. If charter is delayed by JT's due to weather conditions, previous charter, or equipment malfunction, time will be added or rain check given for lost time. I understand that it is my responsibility to inform my group of free parking in grass circle, any fees, restrictions or permission needed at and directions to loading location with map shown on <http://www.jtsboatrentals.com/JT's%20Directions.htm>. I verify that I have seen the boat online and accept as is. JT's does not arrange parking passes or endorse any parks, marinas, homeowner's property, Army Corps of Engineers land/lake shore, etc., as travel time to other locations comes off rental time. *Please note: charter time begins when vessel leaves home slip* and ends when it returns to same slip.* *Entire party must be loaded and unloaded within 30 mins. before or after rental time. No lifeguard is onboard. No pets, diving, fighting, glass or fishing. I acknowledge that JT's has the right to terminate the charter at any time if the operator decides that it is unsafe to continue the charter because of weather or unruly behavior. Individual(s) may be required to disembark vessel so that the charter can continue without incident. **All those entering the water must wear swim attire and a life vest that must not be removed while in the water. JT's highly recommends that non-swimmers NOT enter the water. Under-age drinking, drugs, weapons, flammables, fireworks, nudity or night swims are strictly prohibited.** Moreover, I agree that I am responsible for my group and can be ticketed and taken to jail by TX Parks & Wildlife. JT's accepts no liability and recommends a certified TABC server be hired by group to avoid any infractions. **Group will interpret rules to non-English speaking persons.** All participants must sign/print names on liability/swim waiver and receive a safety orientation upon boarding.
